Dear aproquen family:

With a heart full of gratitude, I am pleased to share the achievements of 2023, made possible thanks to your generous support, which has profoundly impacted the lives of thousands of children and their families. While the challenges we face remain significant, your solidarity empowers us to overcome each obstacle with determination and commitment.

This year, we proudly celebrated 32 years of service, providing 693,000 comprehensive and free health services, including 40,153 surgeries and 360,246 rehabilitation sessions. In 2023, we treated 1,367 children with severe burns or congenital malformations, such as cleft lip and palate. These figures represent lives transformed, smiles restored, and children finding a new path to hope. However, the situation we face remains alarming:

90% of burn accidents occur at home, and 57% of the victims are children under five years old, highlighting the urgent need for our work and your continued support.

Through our Prevention Program, we conducted 39 workshops for children and 11 workshops for adults, reaching 21 schools in the departments of Managua, Jinotega, Matagalpa, Granada, Chinandega, and Masaya. These workshops benefited 2,390 children and 427 adults (parents, teachers, and community leaders). These efforts are essential for reducing risks and fostering a safe environment for our children.

Additionally, we held 3 ABLS
(Advanced Burn Life Support)
courses, training 123 healthcare
professionals, and organized 3
Medical Missions to train plastic
surgeons and plastic surgery residents,
strengthening the capacity of
healthcare personnel in Nicaragua.

Through these efforts, we save lives and improve the quality of care for burn patients locally.

A significant milestone this year was the strengthening of infection control practices for burn patients, thanks to the exceptional support of Gretchen Carrougher, MN, RN, CBRN, a distinguished nurse specialist and member of the American Burn Association and the International Society of Burn Injuries. With over 30 years of experience in burns, Gretchen has been instrumental in improving our nursing practices, offering continuous training for the past 13 years, and leaving a lasting legacy in our Burn Center.

Finally, we successfully supported our sister organization in Costa Rica with burn prevention efforts, replicating our comprehensive care model and expanding our impact beyond borders.

None of this would be possible without the unwavering support of each and every one of you. You are the driving force behind these achievements, and together, we will continue transforming lives.

- aproquen provides free room and board for families in need at "Casa Albergue" so they can stay close to their children while they receive treatment.
- aproquen also provides formula and special bottles to help replace the caloric intake loss of those children born with cleft lip and palate.



- To decrease the incidence and prevalence of child burns, aproquen's burn prevention team conducts educational prevention workshops at pre-schools and elementary schools throughout Nicaragua's most underserved and high-risk communities.
- Due to limited access to health services in rural areas, aproquen's medical team provides an online course to teach health professionals how to stabilize a patient in the first 24 hours after a burn.

• With the support of different media outlets in Nicaragua, aproquen conducts an ongoing public education campaign for burn prevention.





A PARENTS HEALING LOVE:

Naheslyn's story.

Welcoming a newborn child often entails embracing a new challenge regardless of the circumstances, a reality Jordy and Yunieth faced head-on as they greeted their daughter Naheslyn into the world, who was diagnosed with cleft lip and palate. For a family of four surviving on approximately fifty dollars a month in Chichigalpa, the thought of covering the medical expenses associated with such a diagnosis was daunting.



Despite facing extremely challenging circumstances, Yunieth and Jordy refused to lose hope for their youngest daughter's ability to thrive. They discovered a pathway through aproquen, where the generosity of donors played a crucial role in Naheslyn's recovery, given her family's limited resources. At times, her parents had to make sacrifices, forgoing basic necessities to afford transportation and medical expenses. It was the kindness of our donors that enabled Naheslyn to begin her treatment, ultimately enhancing both her health and quality of life.

Following several initial outpatient visits with various specialists at aproquen, Naheslyn underwent her first lip closure surgery in march 2023, marking a significant milestone. However, her journey to recovery was far from over.

On January 16, 2024, Naheslyn underwent a second surgery to close her palate. The family's modest home mirrored the challenging conditions they faced, lacking rooms or luxuries. Despite these obstacles, with the unwavering support of her parents and the medical team, Naheslyn achieved a complete recovery.

Throughout this challenging process Naheslyn's family was determined to provide her with the joyful life she deserved. It was the dedication of the aproquen team that granted Naheslyn a second chance at life. Naheslyn's story is just one among many, and it is through your generosity that we can transform tears into smiles.

A POWERFUL Story of resilience

Imagine a typical morning for most 5-year-olds: being gently awoken by their parents, enjoying a hearty breakfast, and then heading off to school to see friends and learn from a nurturing teacher. However, this scene is a far cry from the reality for many children like Elder Lanuza, growing up in developing countries such as Nicaragua.



Born in the Caribbean Region of Nicaragua, Elder's mornings are spent waking up early to assist his family on their farm, where even young children are required to work the land to make ends meet. Despite the inherent risks involved, on this fateful day, Elder and his two siblings were tasked with preparing the ground for a new harvest by setting the area ablaze. Although this task was routine, disaster struck when Elder lost his balance and rolled onto the burning ground, severely burning half of his body.

Following the accident, Elder was urgently taken to the aproquen Burn Center and immediately placed in the ICU. The severity of his injuries led to additional medical complications, necessitating the involvement of a multidisciplinary team of specialists dedicated to providing the comprehensive care he needed as he fought for his life. Elder spent 51 days hospitalized, 45 of which were in the ICU. During this harrowing time, he experienced a heart attack and became non-verbal.

Despite his critical condition, Elder began to slowly make progress and was eventually released from the hospital.

Elder's journey toward recovery showcased his incredible resilience. Though his case was severe, the aproquen team remained unwavering in their commitment to his survival, giving him a renewed opportunity for life.

We are deeply thankful for the ability to offer comprehensive, cost-free care to Nicaraguan children like Elder, made possible through the generosity of our donors. 



2023 Financials

Giving Back in Gratitude: The Story of Ulivian Pellas

Dear Friends,

I would like to share with you a very personal story about an experience that completely changed my life and opened my heart to the world of burned children.



On October 21, 1989, my husband Carlos and I boarded a 727 of the Honduran airline TAN SAHSA, traveling from Managua to Tegucigalpa. Unfortunately, the plane never made it to Tegucigalpa, and instead crashed into Cerro de Hule at 7:50 a.m. The accident was described as the most tragic event in the history of Central American aviation as 139 lives were lost and only 10 survived.

Thanks to my husband who pulled me from the flames and God who is always watching over us, Carlos and I survived.

As I was drifting between life and death while being transferred via air ambulance from the hospital in Tegucigalpa to the United States my father heard me mumbling, "I am going to build a unit for the care of burned children." In gratitude to God that it had been Carlos and I and not our children that suffered the accident, I turned that thought into a commitment: aproquen was born in this moment.

I can assure you that burn injuries challenge the boundaries of one's threshold for pain. There were many times that I felt the smallest increase in the intensity of my suffering would most certainly be the cause of my death. But, it was not my time, and my life was ultimately spared after enduring the torturous pain caused by both my burn injuries and the 62 fractures across my face and body.

Today, there no words that can explain how I am still here. Every moment of every day I remember how lucky I am to be able to share new experiences with my husband, children and grandchildren.
